HACA Wants to Invest in Your Education!

HACA and its nonprofit subsidiary Austin Pathways have awarded more than \$1 million in scholarships to public and assisted housing residents over the past 15 years.

Scholarships serve as vehicles of hope to individuals who want to earn a degree, but do not have the money to attend college. Scholarship awards also are often an inspiration to become independent and economically self-sufficient.

Eligibility

Applicants for a scholarship must be a current HACA public housing resident or Housing Choice Voucher (Section 8) participant; a graduating high school senior or already have high school diploma/GED; and currently attending or planning to attend a college, university, technical school or other post-secondary school.

If you are currently attending or attended a post-secondary school previously, you must have a cumulative GPA of 2.0 or greater (transfer credits are not considered in this GPA).

"I felt a lot of pride when my children saw mama trying, mama doing, and mama being successful," she said.

Jobs Plus is a program that helps residents at Booker T. Washington Terraces and Chalmers Courts work their way to careers and self-sufficiency. The Jobs Plus team assists residents by connecting them with partner organizations who specialize in various employment services, by providing financial incentives that make work pay and by building a community that will support and celebrate working residents.


Mid-Winter Back-to-School Supply Giveaway Set for Jan. 17-31

Tax Time is Around the Corner

The most wonderful time of the year is approaching – no, not the holiday season... tax season! Not looking forward to doing your taxes? Foundation Communities can help you get everything together before April 18.

Foundation Communities will provide free tax preparation services at six convenient locations throughout Austin and in Round Rock to anyone who makes less than \$55,000 a year.

In 2016, Foundation Communities' IRS-certified volunteers prepared more than 20,000 tax returns resulting in \$34 million in local tax refunds.

The IRS will hold all refunds on returns that include the Earned Income Tax Credit or Additional Child Tax Credit until Feb. 15. It is a new law that applies to everyone, regardless of who prepares the return, and no one can speed up the refund.
