Residents Victorious at TDHCA Meeting

More than 50 public housing residents attended a Texas Department of Housing and Community Affairs (TDHCA) board meeting in Downtown Austin to speak up for HACA. HACA went before TDHCA to ensure the agency received enough tax credits to make much-needed improvements to its public housing properties through the Rental Assistance Demonstration (RAD). These improvements, which include garbage disposals, ceiling fans and washer dryers, will also improve quality of life for HACA's public housing residents. Residents made signs in English and in Spanish that read, "Public Housing Residents Deserve Full Funding Credit Too." Several also prepared speeches. Congratulations and thank you to everyone who helped make this meeting's outcome a unanimous success!
