

## Maktam de Juur ɛ yōöt ke Akuma Pandīt de Austin Akum de Nyoth de Kony ye cɔl RAD Lëk ɛbën

Maktam de kɔc ke yōöt tɔ paan dīīt dɛ Austin (HACA) ee wēt jōt thiekic bɛi bei nɛ lōōŋɛ juurɛ yōt nɛ pandīt de Austin ku yen abɛ pīrɛ kɔc juīɛc ke Austin wār ɔlīp kee ŋuan (4,300) ku buɔt kee diāk ye rōth gɛi nɛ juur ɛyōt kee Akuma waar.

Naa mäte rɔt Akutnhōm de Amirka ye yōöt juōōr ku juēērɛ madīnai ye cɔl U.S. Department of Housing and Urban Development (HUD) nɔŋ ajuɛɛr den ye cɔl Kony de Juurɛ yōöt - Rental Assistance Demonstration (RAD), ke **Maktam de** HACA ɔlɛu bɛ wɛu yee ke kɔc arɛēt cuat piny acān benɛ ke apāc ku pinyden cɛ naŋ run juīɛc gam tɛ nɔŋ kɔc ye dɔm nɛ wɛu lik lɛu bīke cɛŋ nɛ ruɔn kōk kee thiɛŋuan (40). RAD abɛ kony dīt bɛi bei benɛ kɔc ye piiny juur kuɔny tɛ kɔc kek bikɛ yōt ken waar ka bīk ŋoot ɛkeɛ lɔ tuɛŋ thīn.

Kājuɛc tɔ nɛ RAD

RAD ee gɔl HUD ben biliaar ke thiɛrou ku dhetem (\$26 billion) dolaar ke Amirka ci kuet nɛ juuric cool ku cōkpiny de bɛi. Nɛ RAD cōk, yōöt ŋoot (ku ka lɔ ekee riāāk) ke wɛu ke akuma yɛnɛ kɛ yōt juur aa keek wɛl nɛ juurɛ yōtic. ɛkɛnɛ ɛke maktam de kɔc ye yōöt juōōr yiɛn riɛɛr bīk kɔc yaa kuɔny nɛ cuɛtpiny de wɛu bɛnɛ kɛ yōt ya yiɛknhial ka benɛ ke yōt cɛ nāŋ ruɔn juɛc cīic bīk cɛŋ.

Kɛ yee RAD kuɔny kɔc yɛ juōōr?

- **Gɛl.** Raan juōōr ɛbɛn anɔŋ lōŋ bɛ cɛŋ nɛ yān ke Akuma ku lɛu bɛ bɛɛr lɔ tɛ den cɛ cīic ka ci yiɛknhial. Juur ee ya thiɛrdiāk nɛ buɔtic (30%) cɛ thōōŋ kenɛ wɛu ye yōt ke b ɛi, ku ɔcin raan lɛu bɛ bɛr caar nɛ lɔŋ de reec.
- **Cōkpiny.** Kājuɛc ɔlɛu bɛkɛ wāār, ku yān kōk ɔlɛu bike cōkpiny, bi ke cīic kur juirke bīk karaba koor ya lōōm. Kɔc juōōr ɔlɛu bike naŋ yic nɛ juɛrɛ yiɛknhial bike ka ken dɛk kɛ keek ya yōk.
- **Lōc.** Kɔc ŋoot ɛkeɛ juōōr, kɔc piac jōr yōt, ku kɔc nōŋ piōth bɛn, aalɛu bik thiōōŋ ku bik rɛɛr tɛ kɔc piōōthken, ku cie bi raan tāāu nɛ yōöt tuɛŋ ci rōt yōk. Kɔc ci dōŋ nɛ yōöt tōōk ke RAD yiic nɛ run ke rou ɔlɛu bikɛ thiōŋ nɛ wārāgɛk ke yōt nhiārɛ kek wɛn lɛu bi ke cɔk lɛu thiɛc nɛ yōt cie kakɛ Akumā yekɛ riɔpic tɔ thuk.
