HACA Section 3 Program

HACA is committed to **helping the residents** of its public housing communities, its Section 8 Housing Choice Voucher holders, and other qualified **low-income persons** residing in the Austin-Round Rock-San Marcos Metropolitan Statistical Area (MSA) achieve their goals of self-sufficiency. To achieve their goals of self-sufficiency. To achieve this, HACA, its staff, contractors and subcontractors will comply with the requirements of Section 3 of the Housing and Urban Development Act of 1968.

Section 3 requires that, to the greatest extent feasible, **training**, **employment and other economic opportunities** generated by HUD funds be directed to low-income residents, particularly those who are recipients of government assistance for housing, and to **award contracts** to eligible businesses that provide economic opportunities for these persons.

Section 3 promotes **self-sufficiency** by making available **job training**, **employment and contracting opportunities**. By providing this foundation together with other community resources, the opportunities for economic advancement and self-sufficiency are increased.

Who are Section 3 Residents?

All residents of HACA public housing developments and HACA's Section 8 Housing Choice Voucher (HCV) holders qualify as Section 3 residents. Additionally, other low-income persons residing in the Austin-Round Rock-San Marcos MSA qualify for Section 3 status.
