

At the moment, vaccines remain in limited supply, so please continue to take the CDC's recommendations to stop the spread and stay safe, stay home if you do not feel well, and consult your medical provider with any specific questions or concerns.

Who is Eligible to get Vaccinated at this Time?

Here is the latest statement about vaccine eligibility in Texas, taken directly from the Texas Department of State Health Services (DSHS):

At this time, individuals in the Texas DSHS definition of Phase 1A and Phase 1B are eligible to be vaccinated. However, there is currently not enough vaccine supply in our area to meet the demand for everyone who falls within these categories.

- illness from the virus that causes COVID-19

As vaccine availability increases in 2021, people will be able to get vaccinated at doctor's offices, pharmacies, hospitals and other temporary sites. You should contact your regular provider of vaccines to see whether they will be a provider of the COVID-19 vaccine.

• **Phase 1A:** Front-line healthcare workers and residents at long-term care facilities • **Phase 1B:** People 65 years of age and older; people 16 years of age and older with at least one chronic medical condition that puts them at increased risk for severe

COVID Testing Coming to Four HACA Properties

Elite DNA Screening, a vetted partner, will be administering a saliva-based COVID-19 test at four HACA properties in February. Elite DNA Screening staff will be going door-to-door to give the test to any resident that is home and wishes to participate. The tests are free, and results will be given in 2 to 3 days.


Testing will take place at four properties according to the following schedule:

- Lakeside: Feb. 3, Feb 10.
- Rosewood-Salina: Feb 4. Feb. 11
- Gaston Place: Feb 4, Feb. 11
- Northloop: Feb. 5, Feb 12



Please note that these tests will be taken by collecting saliva in a small tube (as pictured). This method is easier and more comfortable to give than the nasal swab.





Since the holidays, Austin/Travis County has been in Stage 5, which is the highest level for Community Risk. Early to mid-January saw positivity rates for COVID-19 rise, and space in hospitals became scarce. In other words, all HACA residents and staff MUST remain vigilant and follow the recommendations of health professionals at the CDC and on the local level with Austin Public Health.

Smoking is Not Permitted Inside Any HACA Building or Apartment

Property management has received complaints from resident council leaders indicating that there has been an increase in smoking inside units during the time of the pandemic. Please remember that HACA buildings and units are Smoke-Free. Residents are only permitted to smoke in designated smoking areas. Smoking in your home is a potential for lease enforcement for violating the policy.

- 1. All HACA properties remain smoke-free. Covid-19 has not changed this policy.
- 2. With more people staying home due to Covid-19, this is even more important for the health of all residents. We have more people at home not wanting to breathe the cigarette smoke from their neighbors.
- 3. Smokers can still smoke in designated smoking areas or on the sidewalks of City streets (but not on the sidewalks within the property).
- 4. The current CDC Eviction Moratorium only applies to nonpayment of rent. The consequences for violating the smokefree policy are still in place.
